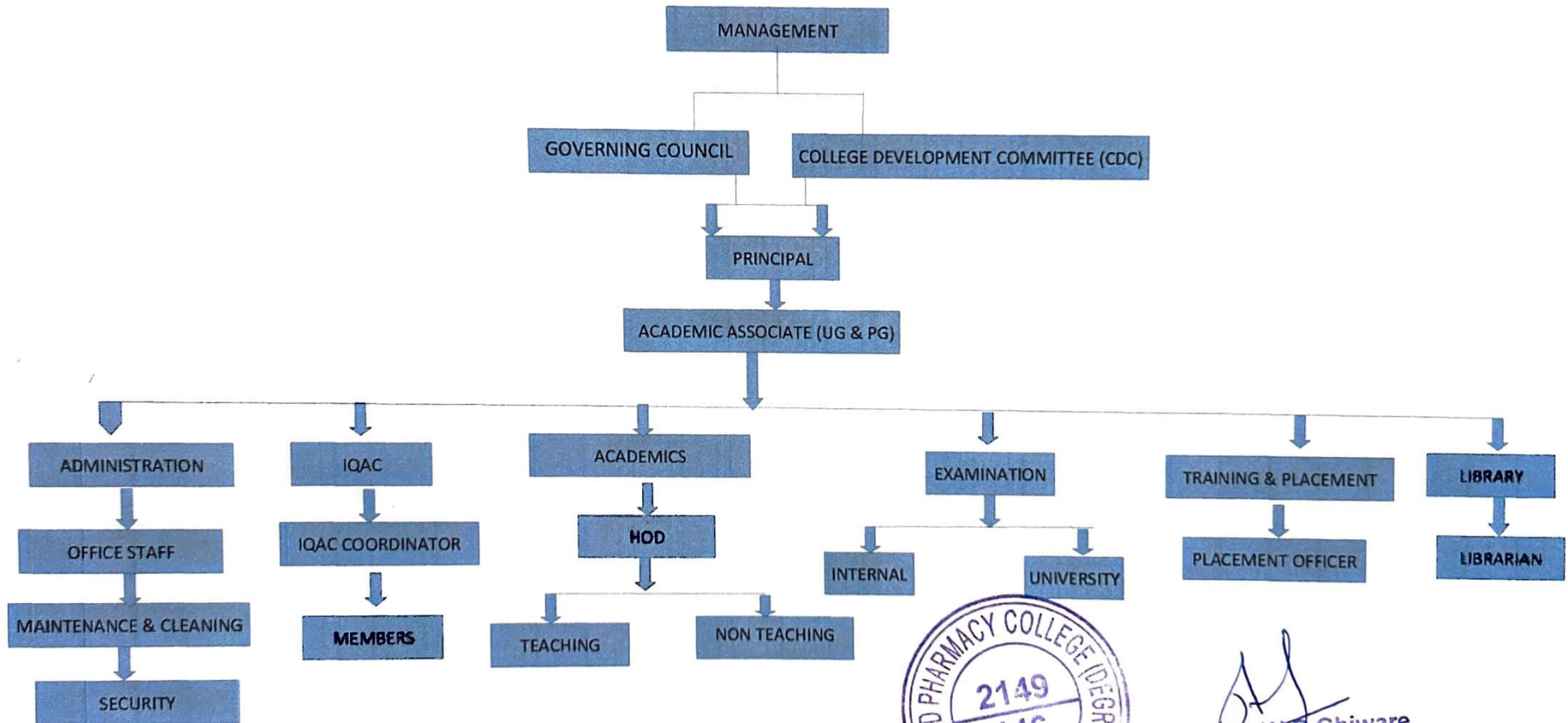

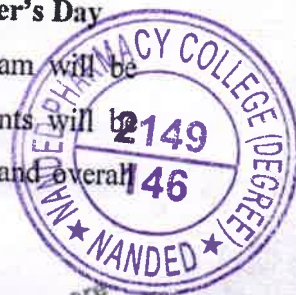
#### Planning and execution of Induction program for first year students &/ fresher's Day
